BE IT REMEMBERED, that on this 11th day of October, 2017, an Agenda Preparation Session of the Hamilton County Board of Commissioners was begun and held at the Courthouse, in the City of Chattanooga, in the County Commission Room, when the following proceedings were held, to wit:--

Present and presiding was the Honorable Randy Fairbanks, Chairman. County

Clerk Bill Knowles called the roll of the County Commission and the following,

constituting a quorum, answered to their names: Commissioner Bankston,

Commissioner Beck, Commissioner Fields, Commissioner Graham, Commissioner

Mackey, Commissioner Martin, Commissioner Smedley, and Chairman Fairbanks.

Commissioner Boyd was absent. Total present – 8. Total absent -1.

Also in attendance were County Mayor Jim Coppinger, members of his administrative staff, County Attorney Rheubin Taylor, and County Auditor Jenneth Randall.

COMMITTEE ASSIGNMENTS

Chairman Fairbanks indicated the upcoming agenda items would be considered as follows:

- The Juvenile Court Clerk's report for May 2017 would be submitted as a matter of record.
- Unaudited Financial reports for fiscal year ending June 30, 2017 for Circuit Court Clerk, Clerk and Master, County Clerk, and Register would be submitted as a matter of record
- An Order of Designation to the Planning Commission would be submitted as a matter of record.
- Resolution No. 1017-23 was the usual County Clerk item regarding notaries, etc. This required no committee assignment.
- Resolution Nos. 1017-32 through 1017-33 were assigned to the Finance Committee, chaired by Commissioner Smedley.
- Resolution No. 1017-34 was assigned to the Zoning Committee, chaired by Commissioner Bankston.
- Resolution Nos. 1017-24 through 1017-29, and 1017-30A, 1017-30B, 1017-31A, 1017-31B, and 1017-35 were heard by a Committee of the Whole.

COMMITTEE OF THE WHOLE – RESOLUTION NOS. 1017-30A AND 1017-30B

Karen Rennich, Deputy Director of the Regional Planning Agency, spoke regarding these items, which rezone from A-1 Agricultural District to R-1 Single Family Residential District, property located in the 7300 block of South Dent Road. Ms. Rennich provided details and stated the applicant wished to withdraw the application.

There were no questions from Commissioners.

COMMITTEE OF THE WHOLE - RESOLUTION NO. 1017-31A AND 1017-31B

3:32

Karen Rennich, Deputy Director of the Regional Planning Agency, spoke regarding these items, which rezone from A-1 Agricultural District to M-1 Industrial District property located in the 9000 block of Bryan Road. She clarified 1017-31A is the applicant's request, and 1017-31B includes conditions as recommended by the Planning Commission. It was noted the applicant, Greg Krum with Birchwood II, LLC, was present; a large number of opponents were also present. Ms. Rennich presented details regarding the project, which proposes to develop a 25-acre site for a future construction and demolition (C&D) landfill. The proposed entrance to the site would be off Birchwood Pike through the existing City landfill. A copy of Ms. Rennich's presentation was filed in the Clerk's Office.

Ms. Rennich reported the proposal came out of Planning Commission with a recommendation to approve with certain conditions, including its use be limited to a C&D landfill only. The applicant must also obtain a letter from Hamilton County Groundwater Protection indicating approval of the site with regard to the septic system, water supply, drainage characteristics, and general site suitability. She added the City of Chattanooga has approved the site access through the existing landfill, which will be addressed by Commissioners later in the meeting during discussion of Resolution No. 1017-35.

At this time, Ms. Rennich answered several questions from Commissioners. She confirmed the proposed landfill is on property adjacent to the City's existing solid waste landfill and will be operated privately. Ms. Rennich clarified conditions approved by the Commission could only be lifted by the Commission.

14:38

The applicant, Greg Krum with Birchwood II LLC, residing at 5857 Canyon

Pass Court, Ooltewah, TN 37363, presented additional details regarding the project.

He stated there is a need for a C&D landfill as currently the closest construction

debris landfill is in Bradley County. It was noted the only other C&D landfill in

Hamilton County closed in March. A copy of the applicant's presentation was filed in
the Clerk's Office.

Dr. George Hyfantis, hazardous materials consultant for Birchwood II, presented details about the completed environmental studies, including how the group plans to collect and treat leachate, which comes from water traveling through the landfill and picking up chemicals, if any is produced. He noted the Tennessee Department of Environment and Conservation (TDEC) requires a 100 foot buffer around the property where no waste will be placed, which will act as a liner.

Dr. Rick Sinclair, a consultant for Birchwood II, also spoke on behalf of the applicant. He stated that as a former TDEC deputy commissioner he is aware that entity oversees all development and operations of these types of facilities. He reported TDEC rules and regulations must meet or exceed those of the Federal Environmental Protection Agency (EPA). He noted these regulations are designed to protect the environment and groundwater.

24:48

At this time, a lengthy discussion took place between Commissioners and Mr.

Krum, Dr. Hyfantis, and Dr. Sinclair regarding TDEC regulations, which include a requirement that the development be a minimum of 500 feet from the nearest residence.

Additional topics included managing leachate, preventing rodents, management and regulation of hazardous materials, and oversight of the landfill. It was noted TDEC performs random inspections of C&D landfills to check for hazardous materials.

Chairman Fairbanks asked those present in opposition to come forward at this time.

46:00

Ernie Burfitt, residing at 8708 Danny Lane, Harrison, TN 37341, gave a presentation in opposition to the proposed development. He distributed a handout to Commissioners, which included a petition with 2,100 signatures of community members opposing the site. Mr. Burfitt reported he is the pastor of New Bethel Baptist Church in

the Harrison community and was asked to speak on behalf of community members opposed to the landfill. He spoke at length about precedent and referenced two prior cases in 1971 and 2007 (*Resolution No. 1207-12*) in which the Commission denied the rezoning of this property for the use of a landfill. Additional concerns included environmental and groundwater protection, toxic waste getting into the landfill, possible contamination to the nearby lake, and worries the owners might decide to pull out, which would leave the County responsible for cleanup.

Mr. Burfitt reported the landfill would decrease home and property value in the area and would provide no economic benefit to the County. He also presented the possibility of TDEC later reclassifying the type of waste this landfill would accept at the applicant's request and without public notification, including hazardous waste. A copy of the handout and Mr. Burfitt's presentation was filed in the Clerk's Office.

1:00:35

Andy Mullins, who is currently building a home at 6041 Morning Glory Drive,
Harrison, TN 37341, which is less than 3,000 feet from the proposed development,
spoke in opposition to the landfill. Mr. Mullins reported he is the Chairman of the
Hamilton County Health and Safety Hearing Board, but is speaking today as a private
citizen. He voiced concerns that the site's property line is 47 feet from a residence and
58 feet from a main water source. He encouraged Commissioners to visit the site.

At this time, a lengthy discussion took place among Commissioners and Mr. Burfitt. Topics included TDEC regulations, legalities of dumping mattresses, and prior decisions regarding this property. Attorney Taylor stated he would provide additional information regarding the types of applications presented in the 1971 and 2007 rezoning cases.

John Chenkus, residing at 6117 Morning Glory Drive, Harrison, TN 37341, Lisa Davis, residing at 7370 Emanon Road, Harrison, TN 37341, Sam Wells, residing at 6235 Morning Glory Drive, Harrison, TN 37341, and Deborah Chenkus, residing at 6117 Morning Glory Drive, Harrison, TN 37341 all spoke in opposition to the proposed development. The each provided details on the negative impacts the landfill would have on their community.

At this time, Chairman Fairbanks gave the applicant an opportunity to respond to comments made during the opposition's presentation. Mr. Krum reiterated the need for this landfill in Hamilton County. Mr. Hyfantis clarified this Resolution would only approve rezoning and further public notification and environmental studies would be completed before development could begin. Additional discussion took place regarding how potential hazardous materials would be separated from general construction debris.
